PRESS NOTE

Himachal Pradesh Staff Selection Commission today declared the result of Written Objective Type Screening Test for the recruitment of **51** posts {**Gen (UR)-17, Gen (BPL)-06, Gen(WFF)-01, OBC (UR)-08, OBC(BPL)-03, SC(UR)-12, SC(BPL)-01, SC(WFF)-01, ST(UR)-01 & ST(BPL)-01 Total=51**} of **Junior Engineer (Electrical)** (on contract basis) **Post Code: 715** held on **12th October, 2019** as per the award list and ratio approved (1:3/1:4) by the Hon'ble Commission. The requisition to fill up these posts was received from **The Managing Director, HPPTCL Shimla-5** and advertised vide advertisement No. **34-2/2018 dated 19.12.2018**.

In response to this advertisement, **7198** applications were received out of which **5815** applications were provisionally admitted.

The Written Objective Type Screening Test was held on **12th October, 2019** in which **3072** candidates appeared and **2743** candidates remained absent. Out of total **3072** candidates appeared, the following **160** candidates have been provisionally shortlisted for further selection process subject to verification of their eligibility in terms of R & P rules and advertisement at the time of 15 marks evaluation process.

Hamirpur. They are directed to bring all the original Essential Qualification related documents as prescribed in the R & P rules and advertisement 15 marks of evaluation related documents, set of self attested copies of all documents, one ID proof and copy of downloaded application Form. In case a candidate does not appear for evaluation process on the day fixed for evaluation he/she will not be considered for further selection process and no further opportunity will be given thereafter.

Note: The applicants who are in possession of 'Full time Diploma in Electrical Engineering from a recognized Institution/ University with 55% marks' as prescribed in the R & P rules and notified in the advertisement are eligible for this post. The rest of the provisionally shortlisted candidates having other than the prescribed essential qualification in the R & P rules and advertisement need not to appear in the 15 marks of evaluation process.

While every care has been taken in preparing the result, possibility of inadvertent / technical error cannot be ruled out. The Commission reserves the right to rectify the same later on.
