

H.P. STAFF SELECTION COMMISSION, HAMIRPUR
PRESS NOTE

Himachal Pradesh Staff Selection Commission today declared the final result for the recruitment of **267** posts of {**General(UR)=188, OBC(UR)=19, SC(UR)=36 & ST(UR)=24**}= **267** of **Clerk (LDR)**. These posts were received from the various Government departments/Board/Corporations and advertised vide advertisement No. **33-1/2017** dated **8th February, 2017**.

Initially **119** posts were received from the various departments of Government of Himachal Pradesh and were advertised vide advertisement No. **33-1/2017** dated **8th February, 2017**. Later on **156** posts of similar nature were received from some other departments in different spells and clubbed with the already advertised posts as per the approval of the Apex Commission, out of which **8** posts {**General=04 OBC=02, SC=01 & St=01**} of DC Shimla were derequisitioned on the request of requisitioning authority.

The objective type written screening test was held on 14th October, 2017 in which 930 candidates appeared and 401 candidates shortlisted for typing skill test. The typing skill test was conducted on 06.02.2018 and 07.02.2018. On the basis of merit of objective type written screening test and qualifying the skill test, **128** candidates including **04** disable candidates who submitted the requisite disability certificate regarding exemption in typing skill test keeping in view the government letter No. Per(AP.B)B(15)-5/2014-P dated 6th April, 2018, were shortlisted for evaluation process on prescribed parameters as per the government notification parameters dated 17.4.2017 which was conducted w.e.f. 26.06.2018 to 27.06.2018. Maximum marks allotted on account of evaluation based on the notified parameters vide Government Notification No. *Per(AP.B)B(15)-5/2014 DATED 17.04.2017* were **15**. The Commission has compiled the final result of **267** posts of **Clerk (LDR)** on the basis of the marks obtained in written objective type screening test (85 marks) and evaluation process (15 marks).
