**PRESS NOTE**

Mandi.

On the basis of marks of Written Objective Screening test held on 6<sup>th</sup> March, 2016, Skill Tests conducted w.e.f. 21.07.2016 to 29.07.2016 and personal interview conducted on 13.12.2016, the Commission has compiled the result of 29 posts of **Steno-typist (on Contract basis) (Post Code: 455)**. 
