Corrigendum to the Advertisement No. 33-2/2017 dated 16.09.2017


This is with reference to Advertisement issued vide Advt. No. 33-2/2017 dated 12.09.2017 which was published in The Tribune and Divya Himachal on dated ,15.09.2017 vide which 148 posts of Male Multi Purpose Health Worker (On contract basis) Post code 650 in the pay band of Rs. 5910-20200+2800 GP of Health and Family Welfare Department of HP were advertised.

Now the department concerned has sent a letter vide letter No. HFW-H(1)B(12)162/91 dated 26.09.2017 vide which it has been conveyed by the Govt. vide letter No. Health-A-B(1)-12/2006-L dated 28.11.2016 issued by the Principal Secretary(Health) to the Govt. of HP, that one time relaxation has been allowed to such candidates who had obtained their diploma after their Matriculation prior to the date of amendment of R & P Rules on 10.08.2011. As per latest information supplied by department concerned vide letter referred above pertaining to the Post code 650, the Essential Qualification of the post of Male Multi Purpose Health Worker Post Code-650 may be read as under:-

- i) Should be a 10+2 or its equivalent from a recognized Board of School Education/Institution.
- ii) Should possess one and half year Training Certificate as MPW(Male) from a recognized Institution of the State Government.

Note:- The candidate who are only matriculate but had obtained their diploma after their matriculation prior to the date of amendment of R & P Rules on 10.08.2011 shall be entitled for the post of Male Health Worker subject to the condition that candidates will acquire the educational qualification of 10+2 within five years from the date of appointment as per latest R & P Rules for the post of Male Health Worker.

All other terms & conditions as advertised earlier will remain unchanged. This corrigendum is also available on web page (<http://www.hpsssb.hp.gov.in>) of HPSSC Hamirpur for information.
