Whereas, the HP Staff Selection Commission, Hamirpur has issued a Employment Notice on dated 16.09.2016 in which 02 posts of Driver were advertised.

Whereas, the Govt. of Himachal Pradesh has issued Notification No. Per (AP.B) B(15)-5/2014 dated 17.04.2017 regarding discontinue/ dispense with the process of holding interviews in respect of direct recruitment for making recommendations for Class III & IV posts/ services under the State Govt. with immediate effect.

Whereas, the clarification regarding division of 2.5 marks allocated for minimum educational qualifications as per R & P Rules and the competent authorities for issuance of various types of certificates on the basis of which evaluation is to be done has been received on dated 18.07.2017.

Therefore, the selection to class-III posts under the State Govt. shall accordingly be made henceforth on the basis of merit of written examination followed by evaluation, based on the following parameters:-

3. The Mode of selection (Syllabus):

- i) Objective type screening test (MCQ) consisting of General English and Hindi of Eighth standard, General Knowledge including General Knowledge of Himachal Pradesh, Everyday Science, Social Science, Current affairs & Logic.
 - ii) Practical Skill Test (Driving test) will be of qualifying nature for those who qualify the written objective type screening test.
4. **The Commission reserves the right to dispense with the written examination for this post keeping in view the number of applicants viz-a-viz vacancies & other circumstances.**
